



The meeting was chaired by the chairperson Dr B Chandrashekar. He has started the meeting with the welcome address.





The chairperson of the committee has explained all the rules and regulations to be followed by the staff and students.

→ All the committee members were <sup>made</sup> aware of rules of code of conduct instructed by chairperson of the committee.





→ He has explained the code of conduct i.e., rules and regulations of our college to both students and staff.


→ Students were instructed for their proper behaviour while they are in the campus.


→ They also instructed with library and examination rules as they are in first year.


→ With the permission of chair, Librarian and examination branch incharges explained the basic rules that they explain/follow.




