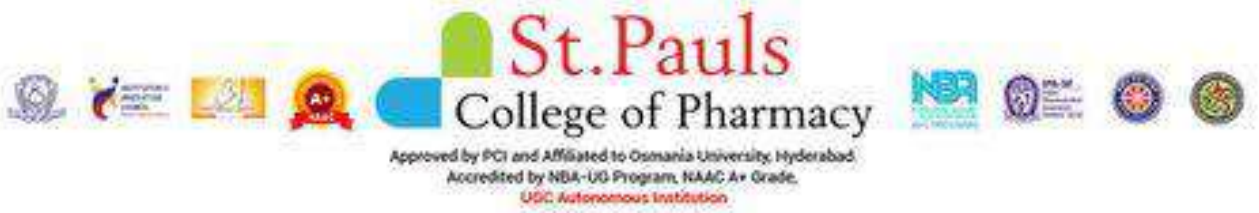

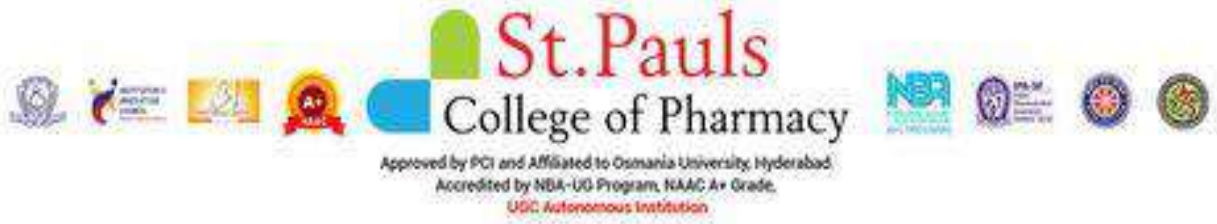

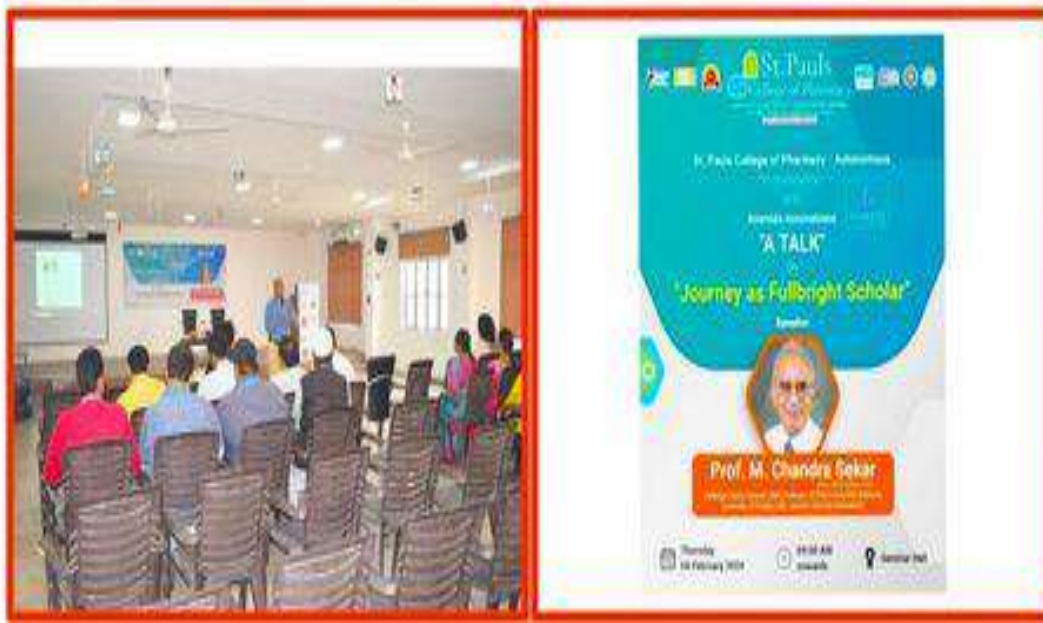
"A talk on journey as full bright scholar"
